Lights focused on Areas J, K, L (Ch. 51-53) & the Stairs (81-83 // 91-92) may be repurposed if the black curtain is used to mask those areas.
Any alterations to the Rep Plot including Specials must be approved by the Technical Director, documented and restored back to Rep after Production. Any Lights/Cables/Accessories added to the Plot must be struck upon completion.
