## Choosing a W-8 form:

Forms W-8BEN (for individuals) and W-8BEN-E (for entities) are the most commonly used W-8 forms. Other W-8 forms available are: W-8EXP, W-8ECI and W-8IMY. Please review all W-8 forms and instructions in order to determine the W-8 that is most suitable for your company.
